## **Notification of Morman Road Closing**

The Butler County Engineer's Office wishes to inform you that Morman Road will close at the CSX Railroad crossing, 0.5 mile north of Stahlheber Road and 0.4 mile south of Ohio 130, for two culvert replacements beginning Monday, September 25, 2017. The culverts are located at the crossing, one on the north side of the tracks and one on the south side. The road is tentatively scheduled to reopen the week of October 23, 2017, weather permitting.

### **The Project**

This project is necessary to replace two aging and deteriorating culverts in an effort to prevent potential future structural failure and maintain proper drainage and water flow. All work is being performed by crews from the Butler County Engineer's Office and funding for the project consists of 100 percent local BCEO Force Account funds.

### **Detour and Maintenance of Traffic**

During this closure, local access to Morman Road will be maintained for residents and businesses from either side of the railroad tracks, but motorists will not be permitted to pass across the culverts or enter the construction zone. Detours will be posted for all thru traffic.

Northbound Morman Road traffic will detour east on Stahlheber Road, north on Boyle Road, and west on Ohio 130 to Morman. Southbound traffic will reverse this route.

Please note that all dates are approximate and may vary due to weather and other factors out of our control which can affect the schedule. Emergency personnel, school bus transportation officials, the post office, and the media have been notified of this upcoming closure.
