2023 Paving of Various County and Township Roads**

Add Sheet: Updated Milford Twp Map.

Change Item: 254E01000A Pavement Planing, Asphalt, Profile 0-1.5", SY, from 838,955 to 839,977.

Change Item: 441E50101C Asphalt Conc. Surface Course, Type 1 (448) APP 1.5", CY from 37,197 to 37,240.

Add Item: 301E46000 Asphalt Concrete Base, PG64-22, 8", 57 CY.

Add Item: 646E10200 Center Line, 0.088 Mile.

Add Item: 646E10000 Edge Line, 4", 0.174 Mile.

Add Item: 646E10100 Edge Line, 4", 0.083 Mile.

Add Proposal Note: Rupp Farm Drive, between Deer Path and Woodbridge Lane (West Chester)

County Forces will close the road to install underdrains and 304 gravel base on Rupp Farm Drive for a section of roadway approximately (100 LF x 23 LF). Gravel wedges will be installed to maintain local traffic. This work will be completed by County Forces by June 9th, 2023. The contractor shall remove gravel wedges, install 301 base course and open the road between June 9th and June 23rd, 2023. Base course shall be installed up to the existing surface course elevation. An area of 400 LF x 23 LF shall be profile milled and surfaced. This work can be done at the contractor's convenience. Coordination of the removal of road closure signage and all other costs associated with this work is incidental to the contract.

Add Proposal Note: Union Centre Blvd. Micro Milling

Grinding and texturing of the existing asphalt pavement shall be completed to improve the surface friction of the roadway and restore proper riding characteristics to the pavement surface. This work shall be done the full width of the roadway. The depth of the milling will be dictated to meet the specification of SS 897.

This work shall be completed during the hours of 9am-3pm, between May 30th and July 30th. A maximum of one lane of traffic will be permitted to be closed at a time.

Clarifications:

Q1: Is Schollenbarger Road being paved in this contract?

A1: No.

Q2: What is the 897 Micro Milling Depth?

A2: Depth is per Supplemental Specification 897 Class B.

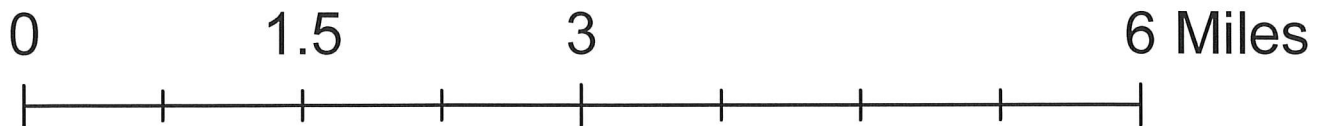
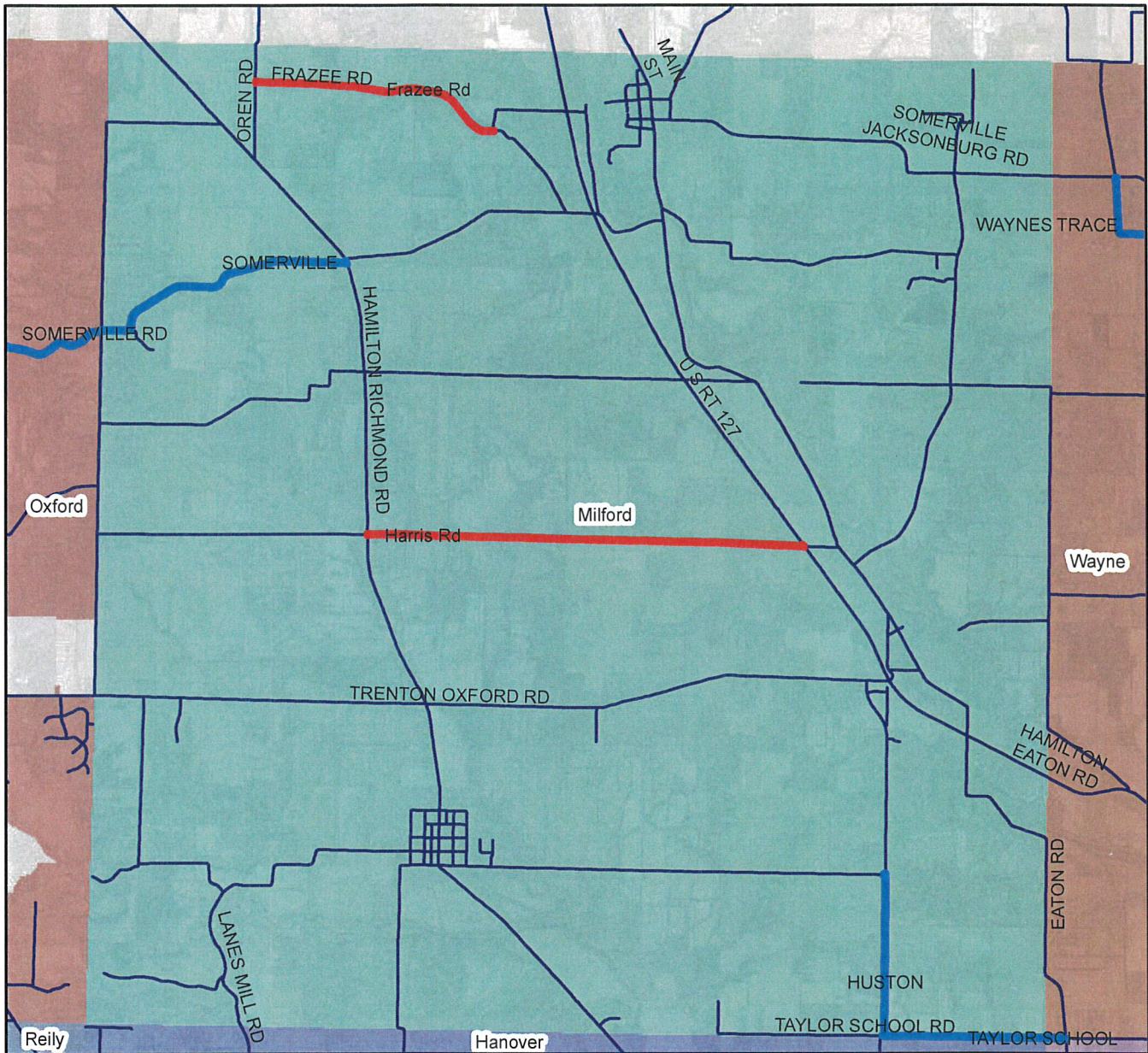
