

EMPLOYEE SELF SERVICE (ESS) - OPEN ENROLLMENT INSTRUCTIONS

Open Enrollment begins in Munis ESS on October 24 and ends November 7, 2023.

In order to use the ESS portal in MUNIS for 2024 benefit selection, you must know:

- Your Employee ID number
- Your Munis ESS password

When you click [Select], ESS will display the various election options:

- Tobacco Free vs. Tobacco User
- High Deductible Health Plan (HDHP) vs PPO
- Coverage Levels: Employee Only, Employee & Spouse, Employee & Children, Family

Select your choice. If you select a choice that implies coverage for dependents, **you are required** to add them to the new election.

If you are enrolling spouses and/or dependents, **you will need their dates of birth and social security numbers**. Medical and dental coverage is available for children up to age 26.

For example, when selecting "Tobacco Free – HDHP – Employee & Family," ESS will tell you to add coverage for at least 2 dependents.



Select your dependent from the "Add existing dependent" drop down. **If you do not see existing dependents, click [ADD NEW DEPENDENT].**

You will get a window allowing you to add the dependent. Enter their information and click [**Save**]. The dependent will be added to your selection.

When finished adding dependents for this election (and adding dependents), click [**Continue**] at the BOTTOM of the page.

You will return to the "**Open Enrollment – Make Elections**" page. Your new 2024 election information will be displayed below the benefit.
