The Board of County Commissioners of Butler County, Ohio met in Regular Meeting on the 26th day of August, 2025 in the Commission Chambers of the Butler County Government Services Center, 315 High Street, 2nd Floor, Hamilton, Ohio 45011.

**Whereas**, pursuant to Section 5577.08 of the Ohio Revised Code the Board of County Commissioners is required to classify the county and township roads and bridges and all other roads and bridges within the County, except state highways and bridges on state highways, with reference to the maximum weights and speeds permitted on such roads and bridges for vehicles of a weight exceeding five tons for vehicle and load;

**Whereas** the Board has from time to time approved lists as recommended by the County Engineer to establish the maximum weights and speeds permitted on such roads and bridges in accordance with Section 5577.08 of the Ohio Revised Code;

**Whereas** the County Engineer recommends that the Board approve the attached Load Limit List dated August 11, 2025 to modify and supersede all prior Load Limit Lists; now, therefore, be it
