*** Request For Qualifications ***

Engineering Services – 2026 Multiple Projects

The Butler County Engineer's Office intends to contract for professional engineering services. Firms interested in being considered for a contract to provide the required services shall submit a Statement of Qualifications **no later than 1:30 p.m. on October 16, 2026**. Statements of Qualifications received after this deadline will not be considered.

Statements of Qualifications should include information regarding the firm's history; the education and experience of the firm's owners and key technical personnel; the technical expertise of the firm's current staff; the firm's experience in performing engineering studies and design services; staff availability; equipment and facilities; references; and any previous work performed for the Butler County Engineer's Office.

As required by Ohio Revised Code §§ 153.65–153.73, responding firms will be evaluated and ranked in order of their qualifications. Following this evaluation, the Butler County Engineer's Office will enter into contract negotiations with the most highly qualified firm.

- **Proposal Length:** The proposal shall not exceed 10 pages, excluding resumes.
- **Non-Contact Period:** During the advertisement period, there will be no formal or informal meetings with the Butler County Engineer's Office. Any specific questions regarding the projects may be directed via **email** to the project manager.
- **Project Approach:** A project approach is not required as part of the submittal. For the **Hankins Road Bridge project**, please provide information regarding the firm's previous railroad experience, including any experience working directly with **Norfolk Southern Railway**.

The preliminary project descriptions are as follows:

Name of Project #1: Hankins Road Bridge SFN 0963473

Location: Located 100 feet east of Salzman Road in Liberty/Lemon Townships.

Description: The existing bridge is located over the Norfolk Southern Railroad and will require coordination with the railroad throughout the project. The project will include

replacement of the existing three-span, rolled weathering steel beam superstructure with a new concrete superstructure.

Name of Project #2: Princeton Road Widening

Location: Located between Leeds Lane/Zoellners Place and Walden Ponds Circle in Fairfield Township.

Description: The project is located in Fairfield Township and consists of widening Princeton Road from two lanes to three lanes. The project will also extend the existing sidewalk along the north side of Princeton Road, enhancing pedestrian connectivity and multimodal access throughout the corridor. The total project length is approximately 0.7 miles.
